I agree that the sole remedy of the undersigned shall be, if any, an action at law for damages, if any. In no event will I nor any party claiming through or in place of me, have the right to seek a court injunction to prevent or halt the development, production, distribution or exploitation of the Production.

Producer's rights herein may be freely assigned and licensed to any person, firm, partnership or corporation. I agree that the provisions hereof shall enure to the benefit of Producer and its successors and assigns and are binding upon me and my executors, heirs, administrators and personal representatives. The law of the Province of British Columbia shall govern the terms of this Authorization and Release.

I acknowledge that nothing herein requires the Producer to utilize my appearance in connection with the Production.
